

## FEES TERMS AND CONDITIONS

### School Fees 2023/2024

- “Resident” means that the pupil’s parents/legal guardians are resident in the Republic of Ireland. “Non-resident” means that the pupil’s parents/legal guardians are resident outside the Republic of Ireland. Non-resident pupils must enrol in the school’s Host Family Service.

In order to secure an enrolment at the Lycée Français International Samuel Beckett a deposit of €500 per pupil and an additional enrolment fee of €500 per pupil are payable. These are only payable once an offer of a place has been made by the LFI.

The deposit will be refunded upon departure from LFI on condition that the withdrawal file is submitted via Eduka before 15<sup>th</sup> of January of the year of withdrawal. It is important to note that for the purposes of this clause, the LFI will not agree to any other withdrawal notification process (such as via email or telephone): only the date of submission of the withdrawal file on Eduka will be valid.

Both the deposit and the enrolment fee are non-refundable should the pupil not take up his/her place.

Should a pupil leave the school and re-enrol at a later date, the enrolment fee will not be payable for the re-enrolment.

### 3<sup>rd</sup> Party Fees Payers

An additional charge of €1,000 per pupil per annum is payable by 3<sup>rd</sup> party payers of school fees, such as employers of pupils’ parents/legal guardians. No discount is applicable to this charge.

## Payment Dates for School Fees

- Annual payments must be made by 1st August 2023.
- Payments per term must be made by:
  - 1st August 2023;
  - 1st December 2023; and
  - 1st March 2024 respectively.
- The option to pay in 10 monthly instalments from 1<sup>st</sup> June 2023 to 1<sup>st</sup> March 2024 is also available. To avail of this option please contact us at [accounts@lfi.ie](mailto:accounts@lfi.ie) **before** 1<sup>st</sup> May 2023.

Enrolment at the Lycée Français International Samuel Beckett is an annual contract. Pupils are enrolled, and places are secured, for the full school year. The full school fees for the year are due even if a pupil is unable to attend class for a part of it.

It should be noted that non-payment of fees by the due date may result in the pupil(s) being excluded from school until such time as outstanding accounts are cleared in full. The Board of Management reserves the right both to levy a late payment penalty of 10% in respect of amounts outstanding on overdue invoices and to withhold all school documents from families in arrears.

## Means of Payment

All payments must be made in euros. The following are the only methods of payment accepted by the Lycée Français International Samuel Beckett:

## Discounts on Fees

A discount on basic school fees and initial enrolment fee is available for families with two or more children at the school. This discount is only available to families who pay the school fees by the due date shown on their invoices. The Board of Management reserves the right to withdraw the family discount if fees are not paid on time. The discount is currently:

- 10% for the second (younger) pupil; and
- 20% for the third (youngest) and subsequent pupils.

The Board of Management reviews the level and system of offering discounts annually and reserves the right to change or withdraw the discount in any future year.

## Host Families Co-ordination Service

An annual fee will be charged for access to the school's Host Families Co-ordination Service. If a host family is required, this fee is due at the same time as the deposit and enrolment fee.

- 1<sup>st</sup> year in Host Family programme: €1,000
- 2<sup>nd</sup> year in Host Family programme: €750
- 3<sup>rd</sup> year in Host Family programme: €500

The reduced fees for the 2<sup>nd</sup> & 3<sup>rd</sup> years will also apply from the 1<sup>st</sup> year for siblings of pupils formerly or currently in the Host Family programme.
